Code Part 276 may result in the exemption being denied and/or penalties being imposed, as provided for by applicable law. Any person who knowingly makes a false, fictitious or fraudulent material statement, orally or in writing, to the Illinois EPA commits a Class 4 felony. A second or subsequent offense after conviction is a Class 3 felony (415 ILCS 5/44(h)).

This form may be used to apply for a parade or ceremonial vehicle exemption from the vehicle emissions testing requirement. Illinois State Law (Illinois Vehicle Emissions Inspection Law of 2005 (625 ILCS 5/13C-15(b)(8)(F)) provides an exemption from the vehicle emissions testing requirement for a vehicle that is operated exclusively for parade or ceremonial purposes by a not-for-profit veterans, fraternal or civic organization.

Please type or legibly print and fill out all fields. Failure to complete all fields may result in denial of your application.

Please submit proof of the status as a veterans, fraternal or civic organization, and as a not-for-profit organization. Acceptable proof includes, but is not limited to, articles of organization, by-laws and federal or state tax reporting forms. Failure to submit documentation may result in denial of your application.
