1. A current copy of the insurance policy which clearly indicates the vehicle is insured as a limited, restricted or exhibition use vehicle.
2. Documentation supporting that the vehicle is operated exclusively in organized amateur or professional sporting activities as defined in Section 3.310 of the Environmental Protection Act (415 ILCS 5/3.310).
3. Current photographs of the front, both sides, and rear of the vehicle, including the license plate number.

The undersigned hereby certifies that the statements contained herein are true and correct, and further that the vehicle identified above is used exclusively in organized amateur or professional sporting activities, as defined in Section 3.310 of the Environmental Protection Act (415 ILCS 5/3.310). By affixing his/her signature hereto, the undersigned certifies that he/she is authorized to execute this form.

I acknowledge that the Illinois EPA is authorized to require, and I will disclose, the information requested on this form pursuant to 625 ILCS 5/13C and/or 35 Ill. Adm. Code Part 276. This information shall be provided using this form, or by alternative means, at your discretion. Failure to disclose the requisite information or comply with 625 ILCS 5/13C and/or 35 Ill. Adm. Code Part 276 may result in the exemption being denied and/or penalties being imposed, as provided for by applicable law. Any person who knowingly makes a false, fictitious or fraudulent material statement, orally or in writing, to the Illinois EPA commits a Class 4 felony. A second or subsequent offense after conviction is a Class 3 felony (415 ILCS 5/44(h)).

Application Instructions

This form may be used to apply for a sporting activity vehicle exemption. Illinois State Law (Illinois Vehicle Emissions Inspection Law of 2005 (625 ILCS 5/13C-15(b)(8)(l))) provides an exemption from the vehicle emissions testing requirement if the vehicle is operated exclusively in organized amateur or professional sporting activities, as defined in Section 3.310 of the Environmental Protection Act. "Organized amateur or professional sporting activity" means an activity or event carried out at a facility by persons who engaged in that activity as a business or for education, charity or entertainment for the general public, including all necessary actions and activities associated with such an activity. This definition includes, but is not limited to, (i) rifle and pistol ranges, licensed shooting preserves, and skeet, trap or shooting sports clubs in existence prior to January 1, 1994, (ii) public hunting areas operated by a governmental entity, (iii) organized motor sports, and (iv) sporting events organized or controlled by school districts, units of local government, state agencies, colleges, universities, or professional sports clubs offering exhibitions to the public.

Please type or print and complete all fields on the application. Failure to complete all fields on the application may result in its denial.

Along with the completed application, you must include the following:

1. A current copy of the insurance policy which clearly indicates the vehicle is insured as a limited, restricted or exhibition use vehicle.
2. Documentation supporting that the vehicle is operated exclusively in organized amateur or professional sporting activities as defined in Section 3.310 of the Environmental Protection Act (415 ILCS 5/3.310).
Acceptable forms of proof may include but are not limited to:
 - Proof of admission to an organized amateur or professional sporting activity or event that took place no more than twelve (12) months prior to submittal of the application.
 - A photograph of the vehicle in an exhibition that took place no more than twelve (12) months prior to submittal of the application.
 - Current membership to a sports club.
3. Current photographs of the front, both sides, and rear of the vehicle, including the license plate, taken no more than three (3) months prior to submittal of the application.

The Illinois EPA reserves the right to require a visual inspection of the vehicle at an official inspection facility.

Please be advised that this information must be submitted every two years to retain the exemption.

Information submitted on this form must be legible and all fields completed. Please include the license plate number and your telephone number on all documentation.
